



Tochnog Professional Order Form

This order form and the prices are subject to change without notice. The invoice send to you will contain exactly the prices as listed below, so no extra VAT is added to the prices. In case you need to pay extra VAT about purchases in your own country, you need to pay these taxes yourself. When ordering a license or updates always the latest order form is valid; all old order forms are obsolete.

In case you want to use Tochnog in combination with GID, see www.gidhome.com, you need to buy GID separately.

The USER buys the license for a specific organisation (company, university, etc.). It is not allowed to transfer a license to another organisation.

Pricing (in European Euros)

The following license types are available:

1. Full license. Included is 10 hours support by FEAT, for help with making input files, small programming jobs, etc. These hours are available for a period of one year, and will be registered by FEAT. Commercial calculations are allowed. One year updates of executable. Price 8500 Euro.
2. Academic license. For universities only. No support hours included. Commercial calculations are allowed. One year updates of executables. Price 3426 Euro.
3. Educational license. For universities only. No support hours included. Commercial calculations are not allowed. One year updates of executables. Price 1778 Euro.

Additional executable updates for a period of one year come at the following price:

1. Full license: 1600 Euro.
2. Academic license: 894 Euro
3. Educational license: 814 Euro

These updates can be ordered yearly at the current price level, or for some years ahead with the price level at the moment of ordering. All licenses are permanent; so if you don't order updates your executable remains working. Updates should be ordered before the previous update period, or first license period, has ended. We don't allow to update licenses when the previous update period, or first license period, has expired.

Additional support hours

Support hours exceeding those included in a license come at the cost of 75 euro up to 120 euro, depending on the support topic.

Dongle locked licenses:

All licenses are dongle locked. Presently available for Linux and MS Windows , both for 32 bit x86 and 64 bit x86-64. The USER is responsible of taking care that the dongle is not lost. In case a dongle is lost, purchase of a new version of Tochnog Professional at the normal price is needed.

Different operating systems:

The above prices for the 'license types' and the 'additional executable updates' are for Linux 32 bit and Microsoft Windows 32 bit (on 32 bit computers the memory limit for calculations is 1.8GB). For Linux 64 bit x86-64 and Windows 64 bit x86-64 you need to increase these prices with 50%. Prices for other operating systems are on demand. On very old linux computers tochnog may not be able to run. The user is then responsible of installing a new linux version on his/her computer.

Bugs

Even if you don't have support hours, FEAT still will solve bugs if you are in the first license year, or if you are in a year for which you have ordered executable updates. If a problem is a bug or not (user input file error, etc.) is at the judgement of FEAT. We only solve bugs in the last distributed version.

Conditions

The conditions are subject to change without notice. By using the Tochnog program you agree to fully understand and accept these conditions.

Limited use of software license

This agreement contains the FEAT Limited Use Software Agreement (AGREEMENT) which will govern the use of the FEAT Tochnog Professional program.

YOU AGREE TO THE TERMS OF THIS AGREEMENT BY THE ACT OF INSTALLING THE SOFTWARE ON YOUR COMPUTER SYSTEM. DO NOT ATTEMPT TO INSTALL

THE SOFTWARE WITHOUT FIRST READING, UNDERSTANDING AND AGREEING TO THE TERMS AND CONDITIONS OF THIS AGREEMENT.

Grant of License

FEAT hereby grants to the user whose details are set out in the order form (USER), and the USER accepts, a limited license to use a Tochnog Professional version, users manuals, and any related materials (collectively called the SOFTWARE in this AGREEMENT). USER may install the SOFTWARE in only one location on a single disk or in one location on the temporary or permanent replacement of this disk. If USER wishes to install the SOFTWARE in multiple locations, USER must license an additional copy of the SOFTWARE from FEAT. USER may not transfer or sub-license, either temporarily or permanently, the right to use the SOFTWARE under this AGREEMENT without the written consent of FEAT.

Term

This AGREEMENT is effective from the day the USER receives the SOFTWARE.

FEAT's rights

USER acknowledges that the SOFTWARE is the sole and exclusive property of FEAT. By accepting this AGREEMENT USER does not become the owner of the SOFTWARE, but USER has the right to use the SOFTWARE in accordance with this AGREEMENT.
